On 9 January 2014, TIH Limited ("TIH") announced that it had entered into an agreement with Cosmic Ventures Limited ("Cosmic") for Cosmic to purchase convertible bonds from TIH. Cosmic is an investment holding company indirectly owned by Mr. Li Tzar Kai Richard, Executive Chairman of Pacific Century Regional Developments Limited, a company listed on the SGX-ST. TIH announced that it had been informed that ASM Asia Recovery (Master) Fund ("ASMARMF") would lend shares in TIH to Cosmic in conjunction with this purchase of convertible bonds.

On 13 May 2014, ASMARMF indeed entered into an arrangement under which it has arranged for 5,000,000 shares in TIH to be available for lending to Cosmic. ASMARMF anticipates that at least some of these shares will be lent by such broker to Cosmic in conjunction with the issuance of the convertible bonds by TIH. ASMARMF can request shares back on customary market timing for settlement.

Kin Chan is the beneficial owner of more than 20% of the issued share capital of Argyle Street Management Holdings Limited, the immediate holding company of Argyle Street Management Limited ("ASML"). ASML manages ASM Asia Recovery Fund, a majority shareholder of ASMARMF. Accordingly, Kin Chan has a deemed interest in the shares in which ASMARMF has a deemed interest.
